<b>Role Title:</b>	Police Constable – Field Intelligence and Operations	<b>Department:</b>	Counter Terrorism Policing South East (CTP SE)
<b>Reports To:</b>	Sergeant – Field Intelligence and Operations	<b>Location:</b>	Kent

<b>Purpose of role:</b>	Field Intelligence and Operations Intelligence team are responsible for combating threats to national security in Kent, together with partner agencies. Mitigation is achieved through the research and development of intelligence and the investigation of Terrorism and Domestic Extremism.
<b>Principle Responsibilities:</b>	The development and investigation of CT/DE intelligence as allocated by the CTPSE Fixed and Operational Intelligence Management Units (FIMU/ OIMU).
	Provide operational support to partner agencies in relation to CT/DE matters.
	To proactively gather and submit intelligence from communities to enhance the CT/DE intelligence picture in line with the CTPSE Regional Control Strategy.
	To assist forces in the planning, intelligence development and attendance (as necessary) of CT/DE impacted events and operations.
	To plan and administer lifestyle management operations around those individuals with relevant CT/DE risk.
	To develop and maintain professional working relationships with internal/external partners (local, regional & national), in order to maximise the exchange of information and intelligence and respond to threats.
	To provide operational resilience to spontaneous, critical and major incidents as directed by CTPSE line management.
	Ensure updates are accurate and timely and actions are completed as per the National Standards of Intelligence Management (NSIM).
	Comply with legislation, policy and Standard Operating Procedures, to ensure the integrity of intelligence operations.
