a. **OVERALL PURPOSE OF THE ROLE**: Defines the role, put simply, why it exists.

The overall purpose of the role is to: Scope, collect, view, assess and investigate data in various forms, maintaining viewing logs to produce and provide an evidential product for use in court. The CCTV Investigator will provide evidence in court when required.

b. **KEY ACCOUNTABILITY AREAS**: Define the important aspect of the role for which the job holder is responsible for results or outcomes.

The key result areas in the role are as follows:

- 1. Scope for CCTV or other media opportunities in relevant areas set by the Senior Investigating Officer to maximise all evidential opportunities.
- 2. Ensure all CCTV and passive data is retrieved and downloaded in its original format to remain compliant with ISO 17025 standards. Lawfully seize all relevant data and complete continuity statements for each exhibit.
- 3. View seized articles including CCTV / DVD, videos and any other audio or visual imagery to prepare detailed and comprehensive viewing logs. Maintain accurate files and logs for each case and provide statements where required in relation to current and historical investigations.
- 4. Prepare detailed viewing logs to identify relevant material in compliance with CPIA 1996 and related guidance to ensure CCTV Investigators support the CCTV Coordinator and disclosure officer. Attend CPS case conferences to assist crown prosecutors with all CCTV evidence and material.
- 5. Liaise and work with other agencies to support Major Crime investigations including the Highways Authority, local councils, public transport and private companies to develop professional relationships. Work in collaboration with FAVU to produce final evidential CCTV compilations for court presentation.
- 6. Attend court and present key CCTV evidence in relation to investigations to assist both prosecution and defence with all aspects of CCTV compilation / presentation.
- c. **DIMENSIONS**: Include matters as key result areas that make the greatest demands on the role holder, seasonal pressures, items processed, the number of customers and/or level of authority to make financial decisions or commit other resources.

Further Comments:

Nature and seriousness of the crimes being investigated adds an extra dimension as this leads to intense scrutiny from both prosecution and defence teams into the work of the CCTV teams.

Requires liaison with partner agencies and private companies to negotiate release or seizure of material. The CCTV Investigator will have to persuade and negotiate with those from both

commercial and private sector in arrange of different scenarios. They will also need to balance competing demands from various investigations.

<u>Designated powers</u> – forensic investigator powers will be used for seizure of CCTV and other digital evidence ensuring compliance with section 19 of PACE. The CCTV Investigator will support Police Officers with the execution of Section 8 warrants for the above utilising the designated investigator powers.

The role holder will be dealing with cases which could be of a sensitive or distressing nature.

The demand on the Major Crime Unit is unpredictable, therefore the role holder may be required to work extended hours and weekends.
