3. Update and complete investigative actions as allocated through relevant systems, ensuring best evidence is achieved in accordance with the aims of the investigative strategy and relevant operating procedures.	10
4. Attend briefings to participate in and where appropriate update the investigation team, identifying pertinent information and bringing this to the attention of the management team as appropriate, urgently if required.	5
5. Prepare written reports summarising lines of enquiry, evidence and other investigative tasks. Conduct necessary administration including creating and maintaining documentation in support of investigative functions.	5
6. Collect intelligence relating to investigations and record this on systems for dissemination, to assist in developing ongoing investigations across the south east region.	5

7. Perform the role of exhibits and disclosure officer for in support of SEROCU investigations and operations as directed.	
8. Engage with other units to achieve the aims of the Operation, to safeguard children and bring sex offenders to justice responding to the results of all deployments recognising the level of threat and harm and responding to tasks promptly and effectively.	
9. Liaise with Forces or other agencies regarding the disclosure of material from UCO operations which may have an impact on the safety or the identification of the UCO and/or operational effectiveness.

<b>Further Comments:</b>
Develop and maintain effective working relationships with collaborative forces across the south east region and other partner agencies.
Conducts witnesses and suspect interviews to obtain best evidence. Conducts investigative actions in a timely manner and to a professional standard. Assist with the evidential review of material seized during premise searches. Assist in the process of viewing digital storage media, e.g. phones, computers and associated storage devices.
Adhere to best practice with exhibit handling, maintaining a clear provenance and continuity during the investigative process through the pre and post trial.
Undertake tasking as directed by the SIO or through the daily investigation meeting. Assist in the collection and flow of sensitive material in relation to domestic extremism and counter terrorism.
