<b>Role Title:</b>	Police Constable – Fixed Intelligence Management Assessor (FIMU)	<b>Department:</b>	Counter Terrorism Policing South East (CTP SE)

<b>Purpose of role:</b>	The post holder will be responsible for receiving, assessing and evaluating intelligence.
<b>Principle Responsibilities:</b>	Gather information / intelligence to inform decision making and you will take ownership of tasking and prioritise any immediate actions based on the threat and risk presented in order to identify further intelligence or evidential opportunities and mitigate any identified threat.
	Act as a conduit for the two-way flow of overt, sensitive and secret information with partners
	Manage intelligence leads for live operations across the South East and will contribute to the development of strategic and tactical intelligence assessments, target and problem profiles and other National Intelligence Model products.
<b>Essential role based training:</b>	This is training that is required but will be provided after appointment.
